## Council of Europe Office in Tirana

As of January 2017, the Council of Europe Office in Tirana, led by the Head of Office, implements eleven projects under the authority of the respective CoE Directorates General. Out of these eleven, seven are part of the Horizontal Facility - a co-operation framework of the Council of Europe and the EU aiming at supporting the Western Balkans and Turkey to comply with European standards, focusing on three areas: (1) Ensuring justice; (2) Fighting corruption, economic crime and organized crime; (3) Promoting anti-discrimination and protecting the rights of vulnerable groups.
